Option Four: Toddler Party

For children aged 1 – 3 years old
Maximum number of children 20

A Toddler Party ensures a great time for children, without the mess at home! It is not only a party for children but for the whole family to enjoy too. The Toddler Party is held in the Crèche, where age appropriate toys and equipment are available to amuse and entertain any child, leaving parents and carers free to enjoy the party.

Toddler Parties include: A member of staff, room hire to include toys and equipment, invitations and food boxes.

How to Book

Payment

A deposit of £50.00 is required, 7 days from the date of booking, with the outstanding balance payable one calendar month before the date of the Party. Once full payment has been received, the party pack can be collected.

Catering

As customers are able to bring their own food onto our premises for Children's Parties, Nirvana Spa & Leisure Ltd accept no responsibility for any illness, injury, loss or damage arising directly or indirectly as a result of the consumption by attendees of food at children's parties supplied by anyone other than Nirvana Spa & Leisure Ltd. We ask all parents hiring the crèche to ensure that food hygiene best practice is followed paying particular regard to the dangers of storage, display and cross contamination risks of perishable food. Additional hot and cold beverages can be purchased from the Café Bar at Pulse 8.

Other details

All children need to arrive in clothing that is appropriate to the party being attended. Please register at Pulse 8 Reception prior to the party, in order to gain access to the relevant rooms. As per the terms and conditions of hire, we ask that you leave the rooms in the clean and tidy state in which you will find them.





TERMS AND CONDITIONS OF HIRE

Deposits

Following your provisional reservation, Nirvana Spa & Leisure Ltd. will require by return, written confirmation, along with a signed copy of the terms and conditions of hire. A £50.00 deposit payment of the final invoice is required to secure the booking. The number of children must not exceed the stated maximum per party. The final payment charge will be due one calendar month, before the date of the party. Deposits are non-refundable but may be transferable to an alternative date, subject to availability. With all bookings, credit card details will be held by Nirvana Spa & Leisure Ltd. as security, in the case of loss or damage sustained to the club, as a result of negligence by the client and/or his/her guests.

Cancellations

In the event of a booking needing to be cancelled by the client, for whatever reason, Nirvana Spa & Leisure Ltd. will make a cancellation charge for the total anticipated loss of revenue to the club on the following basis: 6 months prior to the event taking place, 10% of total value booking, 3 months prior to the event taking place, 50% of total value booking, 1 month prior to the event taking place, 100% of total value booking. In the event of Pulse 8 re-letting the booked facilities, the cancellation charge shall be reduced by the amount of the revenue received, by the club, from such a re-letting. Notice of cancellation must be given in writing.

General

- a) Nirvana Spa & Leisure Ltd. reserves the right to cancel any booking forthwith and without any liability on its part, in the event of any damage or destruction to the club, by fire or, any other cause, beyond the control of the club, which shall prevent it from performing its obligations, in connection with any booking.
- b) If in the opinion of the club, the client, invitees or guest's, act in a manner considered to be prejudicial to the good name of Nirvana Spa & Leisure Ltd, the Club shall be at liberty to terminate the contract, or event forthwith, without being liable for any refund or any compensation to the client.
- c) The club needs to be made aware in advance of the event, of any proposed third party contracts for entertainment or services, for a function and reserves the right to prohibit the same. The Club also reserves the right to determine the level of noise at such an event, the client will be required to adjust this level.
- d) Any alcohol consumed on the premises, during parties, must be purchased from our licensed Café Bar only, for people over the age of 18.





- e) The client will be responsible for any loss or damages, which may be sustained to the Club. If caused by his/her guests in respect of the premises, furnishings or equipment, whether it is caused willfully or by negligence or default, he/she shall be liable for the cost of replacement, or repair, or cleaning, in addition to, compensation for loss of business caused thereby.
- f) The customer agrees to be bound by all reasonable instructions of duly authorised representatives of Nirvana Spa & Leisure Ltd. in respect of the conduct of the party and shall further ensure that those attending shall similarly comply.
- g) Only food and beverage stated in the catering section of the booklet, may be brought in from outside, onto the premises, by the client, invitees or guests.
- h) Any written information made available to the client by Nirvana Spa & Leisure Ltd. shall be deemed to be incorporated herein and in the event of a dispute these Terms and Conditions shall prevail.
- i) No modifications to these Terms and conditions shall be binding upon Nirvana Spa & Leisure Ltd. unless the same is in writing and duly signed by an authorised Manager at Nirvana Spa & Leisure Ltd.
- j) The laws of England shall govern this contract and any dispute referred to the English Courts.
- k) These terms are agreed by both parties.
